Please read this form carefully and be aware that by registering for and participating in this program(s), or by registering your minor child / ward for participation in this program(s), you will be waiving your rights and/or the rights of your minor child / ward to all claims for injuries you or your minor child / ward might sustain arising out of this program(s) and you will be required to indemnify, hold harmless, and defend the College Park Athletic Club and all the employees and agents of College Park Athletic Club and of participation in said program(s).

Credit Card Authorization

Risk of Injury
